

## Savannah Bananas at Disneyland Sweepstakes OFFICIAL RULES

1. **SPONSOR:** Disney Destinations, LLC ("**Sponsor**"), P.O. Box 10,000, Lake Buena Vista, Florida 32830.
2. **ADMINISTRATOR:** Probability LLC ("**Administrator**"), 2 Woodstock Meadows Lane, Woodstock, NY 12498.
3. **ELIGIBILITY:** The Savannah Bananas at Disneyland Sweepstakes ("**Sweepstakes**") is open only to legal residents of the 50 United States or District of Columbia, who are at least eighteen (18) years of age (or the age of majority in the jurisdiction of their residency, whichever is older), and who have Internet access, a valid email address and an Instagram or Facebook account. The drawing will be conducted by Probability LLC, an independent judging organization/Administrator whose decisions are final and binding on all matters related to the Sweepstakes.

8. **PRIZE AND APPROXIMATE RETAIL VALUES ("ARV"):**

**ONE (1) PRIZE ("Prize"):** Winner ("**Winner**") will receive a 3-night vacation to *Disneyland*® Resort in Anaheim, California ("**Resort**") for the Winner and up to three (3) guest(s) (each, a "**Guest**" and together with Winner, the "**Group**") ("**Vacation**") and up to four (4) tickets to the game between the Team and the Indianapolis Clowns scheduled to take place on March 27<sup>th</sup>, 2026 in Anaheim, CA ("**Game**"). Prize is subject to the conditions set forth below.

The Vacation consists of the following:

- Up to four (4) round trip coach airfares for the Group between the major United States gateway airport closest to Winner's residence ("**Departure Airport**") and a Southern California airport ("**Arrival Airport**") as chosen by Disney (with possible layovers); provided, however, if the Winner resides within two hundred and fifty (250) miles of the Resort, airfare will not be provided (airports, airline carriers and flights to be selected by Sponsor in its sole and absolute discretion).
- Up to four (4) round trip ground transfers for the Group between the Arrival Airport and the Resort; provided, however, if the Winner resides within two hundred and fifty (250) miles of the Resort, transfers will not be provided (ground transfers to be selected by Disney in its sole and absolute discretion).
- Hotel accommodations for the Group (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) for up to three (3) consecutive nights at a Resort hotel or Resort area hotel selected by Disney in its sole discretion (standard daily hotel parking at the Resort is not included unless Winner resides within two hundred and fifty (250) miles of the Resort, in which case standard daily hotel parking for one (1) vehicle will be included).
- Up to four (4) 4-Day, 1-Park per day *Disneyland*® Resort tickets (subject to restrictions) for use by the Group for admission to *Disneyland*® Park or *Disney California Adventure*® Park, but not to both Parks on the same day (subject to restrictions). Both a theme park ticket and separate theme park reservation for the same park on the same date are required for park entry for each member of the Group. Theme park reservations and tickets will be required for each day of the visit and must be obtained before visiting.

**ARV Prize: \$7,457.00** which may vary depending upon point of departure. The ARV for the Prize is an estimate made before the Promotion begins. Any difference between the ARV and the actual cost of the Prize will not be awarded.

**Winner must travel on March 25, 2026 - March 28, 2026 to redeem the Vacation and attend the Game. If Winner cannot travel on dates specified by Sponsor, the prize will be forfeited and the prize will be awarded to an alternate Winner (time permitting) from among the remaining non-winning entries received in accordance with these Official Rules.** Once travel is booked, travel dates cannot be changed unless by Sponsor in its sole discretion. If Winner is unable to travel once the travel dates are booked, the prize will be forfeited in its entirety and Sponsor will have no further obligations to the Winner. Prize trip is subject to availability and other restrictions.

In the event the Winner can participate in the Vacation as scheduled but the Game does not or cannot take place as scheduled or at all, for reasons including but not limited to scheduling conflicts, cancellations, postponement, location changes, an event of force majeure, or for any other reason, then Sponsor reserves the right to award the remainder of the Prize (i.e., a trip to Resort) with no further obligation to the Winner. Game is subject to, and Sponsor is not responsible for, changes to production schedule, production exigencies or delays, postponements or cancellation of the Game. Without limiting the foregoing, no cash alternative or prize substitutions will be allowed, except Sponsor reserves the right to substitute prize or portions thereof of equal or greater value if Prize listed or any portion thereof is unavailable for any reason. Prize is not transferable without the prior written consent of Sponsor which may be granted or withheld in its sole discretion and without liability of any kind.
